**Referendum Ballots** are mailed to all Electors that do not reside on We Wai Kai lands. If you do not want to receive a Referendum Ballot package in the mail please contact the Electoral Officer.

If you reside on We Wai Kai lands and are unable to vote in person and would like to receive a mail in ballot package for the Referendum, please contact the Electoral Officer as soon as possible. Requests must be received prior to January 12, 2021.

I will be at the Quinsam Recreation Hall on the 27<sup>th</sup> day of January, 2021, immediately after the close of the Poll, to count the votes and declare the result of the Election and the Citizenship Referendum.
